On November 16, 2012, Respondent filed a request for an extension of time to June 13, 2012, during which she may present proof of passage of the MPRE. In her motion, she indicated that she has taken the November 3, 2012 MPRE but that the results of that examination will not be available until after the deadline has passed for her to report proof that she passed the examination. On November 20, 2012, the State Bar filed an opposition to the motion.

On November 21, 2012, this court issued an order extending the time during which Respondent may present proof of passage of the November 2012 MPRE until ten (10) calendar days after the results of the November 2012 MPRE are released.

On December 13, 2012, Respondent filed a motion for a further extension of time, stating that she received notice on December 3, 2012, that she had received a score of 85 on the examination, one point less than the minimum score required to pass the examination. In her motion, she requested that a stay be issued by this court of any automatic suspension resulting from her failure to pass the MPRE until the instant motion may be briefed and decided.

On December 13, 2012, this court issued an order granting an interim extension of time for Respondent to take the MPRE until this court could rule on the pending motion for an extension after the Office of Probation had filed its response thereto.

On December 17, 2012, the Office of Probation filed an opposition to the requested extension. The opposition focuses primarily on Respondent's alleged non-compliance with various conditions of probation, but provides this court with no case authority in which an extension was denied or disapproved for a respondent who had taken the MPRE prior to the deadline for proving proof of passage but failed the examination.

The fact that Respondent has taken the MPRE and come within one point of passing it provides strong evidence that no danger to the public will result from allowing her several additional months to pass it.



GOOD CAUSE APPEARING and pursuant to rule 9.10(b) of the California Rules of Court, the court GRANTS Respondent's motion to extend the time during which she may present proof of passage of the MPRE. Accordingly, the time in which Respondent must present proof to the Office of Probation of her passage of the MPRE is extended until ten (10) calendar days after the results of the March 2013 MPRE are released.

Except as expressly stated above, the motion is otherwise DENIED. Further, the interim extension of time for Respondent set forth in this court's order of December 13, 2012, is hereby supplanted and extinguished by the above extension.

**IT IS SO ORDERED.**


