
This matter is before the court on respondent Raymond Carl Prospero's July 11, 20102, motion for relief from or extension to pay disciplinary costs. The State Bar filed a response in partial opposition on July 19, 2012. Respondent is representing himself in this manner. The State Bar of California is presented by Assistant Chief Trial Counsel Dane C. Dauphine.

After review of the motion and response, the court DENIES the motion for relief of disciplinary costs, no good cause having been shown.

The court GRANTS the motion for an extension of time to pay disciplinary costs, good cause having been shown. Accordingly, time is extended for respondent to pay disciplinary costs over the next two membership billing cycles due on February 1, 2013 and February 1, 2014.


