On January 9, 2015, **RAYMOND CARL PROSPERO** ("Respondent") filed a Motion For Modification of Probation Conditions, seeking to modify his probation terms by extending the time to pay sanctions and by requesting that the court deem that all documents and reports he has submitted to date, have been submitted timely. Office of Probation for the State Bar of California, by Supervising Attorney, Terrie Goldade, Esq., filed an Opposition To Motion For Modification Of Probation on February 3, 2015. Upon consideration of the pleadings and for GOOD CAUSE SHOWN, this court **GRANTS** Respondent's motion as to modification of his probation by extending to June 30, 2015, the time for Respondent to pay sanctions of \$1,040 to Timothy Krantz and \$250 to the Riverside County Superior Court.

This court **DENIES** Respondent's request that his probation be modified in any manner other than as ordered above, as no good cause has been shown for any other form of probation modification.

**IT IS SO ORDERED.**


