On January 20, 2016, Respondent filed a motion seeking relief from the order assessing costs in the above matters. The amount of the remaining costs is stated to be \$2,905.40. Respondent asks this court to extend the time for him to pay those costs. In support of his motion, Respondent provided a financial statement showing his financial inability to pay the required costs.

On February 5, 2016, the State Bar filed a statement of non-opposition to the request for an extension.

GOOD CAUSE having been shown, Respondent's obligation to pay costs is hereby modified and extended as follows: the sum of the disciplinary costs currently still owed ("Present Balance") will be due and payable in five equal installments, with one-fifth of the Present Balance to be paid by Respondent on or before each of the deadlines for payment of membership fees for the years 2017, 2018, 2019, 2020, and 2021. If Respondent fails to pay any of the above installment payments more than 10 days after its due date without the prior written approval of the State Bar or the State Bar Court, the remaining unpaid balance of the costs will be due immediately and be enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.
