On February 10, 2014, Respondent filed a motion seeking relief from the Supreme Court's order assessing costs in this matter. That order required Respondent to pay costs in two installments, with the first payment due on February 1, 2013, and the second due on February 1, 2014. Respondent paid the first installment, but now seeks relief with regard to the second. In support of his motion, Respondent provided a financial statement and supporting documentation showing his present financial inability to pay the required costs. Respondent asks that his obligation to pay costs be extinguished completely or, in the alternative, extended for at least six months.

On February 21, 2014, the State Bar filed a statement of non-opposition to this court extending the payment deadline to February 1, 2015, but an opposition to the granting of complete relief from the remaining obligation to pay costs. This court agrees with the positions and legal arguments made in the State Bar's filing.

GOOD CAUSE having been shown, the deadline for Respondent to make the second installment payment of costs is extended to February 1, 2015.

The request for complete relief from the obligation to pay costs is DENIED.

In addition to the above, Respondent asked for information regarding the correct amount of the assessed costs. That information was provided in the State Bar's statement filed on February 21, 2014.

IT IS SO ORDERED.
