TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

The court allowed petitioner **Michelle Winspur** to participate in the Alternative Discipline Program (ADP) only if she agreed to be placed on inactive status pursuant to Business and Professions Code section 6233¹ in the above-entitled matter. Petitioner agreed to the inactive enrollment. By order of this court filed, December 19, 2011, petitioner was enrolled on inactive membership. Petitioner's inactive enrollment was effective on January 6, 2012. Petitioner has remained on inactive status since January 6, 2012.

On July 12, 2013, petitioner made her second request for an order terminating her inactive status under the terms of her May 2, 2013 amended Contract and Waiver for Participation in the State Bar Court's Alternative Discipline Program (contract) and the court's Confidential Statement of Alternative Dispositions and Orders (disposition).

Petitioner now seeks an order that will allow her to return to active membership status enrollment. Petitioner supports her petition with evidence that she has not engaged in the unauthorized practice of law since beginning her suspension on January 6, 2012, and that she is in full compliance with the requirements of her enrollment in the ADP. The State Bar does not object to respondent returning to active status effective August 1, 2013.

The court having considered the petition and the attached declaration finds good cause to grant the petition. The court finds, by clear and convincing evidence, that there is no longer a basis for petitioner's involuntary inactive enrollment pursuant to section 6233.

ACCORDINGLY, it is ordered that the petition for transfer to active membership status is **GRANTED**. It is further ordered that the petitioner's inactive enrollment pursuant to section 6233 is hereby terminated and she shall be entitled to resume the practice of law in this state on August 1, 2013 upon her payment of all applicable State Bar fees and previously accessed costs.

IT IS SO ORDERED.


