Come now GERALD W. FILICE (the "Member"), a member of the State Bar, and The
20 State Bar of California, represented by the Office of Chief Trial Counsel, and stipulate,
21 pursuant to State Bar Court Rule 5.132, as follows:

1. The parties previously stipulated to resolution of the above cases which included
23 payment by the Member of the State bar's costs in the matter.

2. Thereafter, those costs were set at \$6,555.00

3. The Member has not yet paid said costs, and, based on the representations of the
26 Member in his Financial Declaration in Support of Motion for Relief (attached hereto), the

4. Unless this stipulation is approved by the Court promptly, after July 2, 2012, the member will be suspended from the practice of law due to nonpayment of these costs.

5. Based on the financial hardship shown, and in the interests of justice, the parties agree that the costs of \$6,555.00 shall not be required to be paid with the Member's 2012 dues, but may instead be paid in quarterly installments of \$546.25 each, commencing October 1, 2012, and continuing the first day of each quarter thereafter until paid in full, the last such payment being due July 1, 2015.
