**ORDER GRANTING EXTENSION OF  
TIME TO PAY DISCIPLINARY COSTS**

On October 18, 2010, respondent filed a motion for an order establishing a payment plan for the \$1,546.00 in disciplinary costs imposed in this matter. The Office of Probation, by Supervising Trial Counsel Terrie Goldade, filed opposition. On October 26, 2010, the court denied the motion on the ground that no financial declaration had been provided to the court indicating respondent's financial condition.


On October 26, 2010, respondent filed a financial declaration in support of his earlier motion. Since that motion had been denied for lack of such a declaration, the court treats his October 26, 2010 filing as a new motion for an extension of time or for a payment plan. No opposition was filed to the financial declaration.

**GOOD CAUSE APPEARING THEREFOR**, the motion is **GRANTED**. Respondent shall pay all outstanding disciplinary costs in three equal payments, on March 1, 2011, March 1, 2012, and March 1, 2013.


