

We have received evidence that respondent Joseph Carlye Barrera, State Bar Number 219583, has been convicted of violating the following:

1. In case number 11-C-14850, Penal Code section 470, subdivision (d) (forgery), two counts, a felony involving moral turpitude;
2. In case number 11-C-11331, Health and Safety Code section 11550, subdivision (a) (under the influence of a controlled substance—methamphetamine and benzodiazepines), two counts, misdemeanors that may or may not involve moral turpitude.

As a result of Barrera's felony conviction for violating Penal Code section 470, subdivision (d), it is ordered pursuant to Business and Professions Code section 6102 that he be suspended from the practice of law effective February 27, 2012, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that Barrera comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.
