On March 16, 2016, petitioner Charlton K. Wordell sought partial relief from an order assessing disciplinary costs in State Bar Court case nos. 11-C-11528, et al. (S230276). The motion for partial relief was based on hardship, special circumstances, and other good cause. On March 17, 2016, the Office of the Chief Trial Counsel of the State Bar of California (State Bar) filed a non-opposition to the motion for partial relief.

Having considered the parties' moving papers, Petitioner's request for partial relief from costs is **GRANTED**, as follows. Good cause having been shown, it is hereby **ORDERED** that the disciplinary costs to be paid by Petitioner in State Bar Court case nos. 11-C-11528, et al. (S230276) is reduced from \$17,875 to \$8,273.¹
