Introduction

This matter is before the court on respondent Judy Lee Bere's March 22, 2013, motion for relief from and/or extension of time to pay disciplinary costs. The Office of the Chief Trial Counsel of the State Bar of California ("State Bar") filed a response in partial opposition on April 5, 2013. Respondent is representing herself in this matter. The State Bar is represented by Deputy Trial Counsel Kim Kasreliovich.

After a careful review of respondent's motion and the State Bar's response, the court **DENIES** the motion for relief from costs, no good cause having been shown.

The court **GRANTS** the motion for an extension of time to pay disciplinary costs, good cause having been shown. Accordingly, respondent will pay disciplinary costs in equal installments with her membership fees due in February 2014; February 2015; and February 2016.
