ORDER RE MOTION TO MODIFY PROBATION

On April 7, 2014, respondent Marvin Ezequiel Vallejo (respondent) filed a motion to modify the terms of respondent's probation in the above-listed matter (modification motion). Specifically, the modification motion sought to terminate the psychological counseling component of respondent's probation. On April 17, 2014, the Office of Probation of the State Bar of California filed a non-opposition to the modification motion.

The modification motion stated specific facts demonstrating that the requested relief is appropriate and serves the objectives of probation. In the modification motion, respondent presented declarations from his therapist, Dr. Robert D. Kendrick. Dr. Kendrick attested that respondent has attended 77 individual therapy sessions. Dr. Kendrick concluded that there has been a substantial change in respondent's condition and that there is a low risk that respondent will repeat this or a similar offense. Consequently, the court finds that the modification motion is consistent with protecting the public, respondent's successful rehabilitation, and maintaining the integrity of the legal profession.

respondent's conditions of probation in the above-listed matter are modified as follows:

The condition that respondent must obtain psychiatric or psychological help/treatment from a duly licensed psychiatrist, psychologist, or clinical social worker a minimum of four times a month (see page 12 of the underlying Stipulation) is hereby removed.
