This matter is before the court on the June 25, 2013, motion of FRANCIS BERNARD MANN, JR., seeking an extension of time to comply with two of his disciplinary probation conditions, partial relief from disciplinary costs, and an extension of time to pay costs. The State Bar's Office of Probation opposes Mann's request for extension of time to comply with two of his probation conditions. The State Bar's Office of the Chief Trial Counsel does not oppose Mann's request for partial relief from costs, but does oppose his request for an extension of time to pay costs.

The court admits into evidence, without objection, both the declaration of Mann, which is attached to his motion, and the declaration of Terrie Goldade, which is attached to the Office of Probation's opposition to Mann's motion. (Rules Proc. of State Bar, rule 5.302(C).)

After balancing Mann's and the public's interests, the court finds that Mann has established that modifying his probation to extend the time in which he must satisfy his probation conditions requiring (1) that he attend and successfully complete the State Bar's Ethics School and (2) that he attend and successfully complete the State Bar's Client Trust Accounting School will serve the objective of probation. (Rules Proc. of State Bar, rule 5.300(B).) Moreover, the court finds that Mann has established good cause for modifying these two probation conditions.

The court also finds that Mann has established hardship, special circumstances, and other good cause to grant him both the requested partial relief from costs and an extension of time to pay the remaining costs. (Bus. & Prof. Code, § 6086.10, subd. (a).)

## **ORDER**

The court orders that the June 25, 2013, motion of FRANCIS BERNARD MANN, JR., seeking an extension of time to comply with two of his disciplinary probation conditions, partial relief from disciplinary costs, and an extension of time to pay costs is GRANTED. Accordingly, the time in which MANN must attend and successfully complete the State Bar's Ethics School (or, in the alternative, complete six hours of Continuing Legal Education in the area of legal ethics) and provide proof of his doing so to the State Bar's Office of Probation is extended until June 21, 2014. In addition, the time in which MANN must attend and successfully complete the State Bar's Client Trust Accounting School (or, in the alternative, complete six hours of Continuing Legal Education in the area of client trust accounting) and provide proof of his doing so to the Office of Probation is also extended until June 21, 2014.

Furthermore, MANN is relieved of paying \$1,143.50 in disciplinary costs. Finally, the time in which MANN is required to pay the remaining \$1,143.50 in disciplinary costs that he still owes is extended as follows: Mann must pay one-half of the \$1,143.50 in costs with his

membership fees for the years 2014 and 2015. If MANN fails to pay any installment as described, or as may be again modified by the State Bar Court, the remaining balance is due and payable immediately.
