The State Bar of California alleges:

### JURISDICTION

1. Janice Marie Crowell ("Respondent") was admitted to the practice of law in the State of California on December 1, 2000, was a member at all times pertinent to these charges, and is currently a member of the State Bar of California.

### **COUNT ONE**

Case No. 11-N-14036 California Rules of Court [Failure to Obey Rule 9.20]

- 2. Respondent willfully violated rule 9.20, California Rules of Court by willfully disobeying or violating an order of the court as follows:
- 3. On or about March 25, 2011, the Review Department of the State Bar Court filed an Order ("9.20 Order") in case number 10-C-10422. The 9.20 Order included a requirement that Respondent comply with rule 9.20, California Rules of Court, by performing the acts specified in subdivisions (a) and (c) within 30 and 40 days, respectively, after the effective date of the 9.20 Order. (A true and correct copy of the 9.20 Order is attached hereto as Exhibit 1 and is incorporated by reference.)
- 4. On or about March 25, 2011, the case administrator of the State Bar Court properly served upon Respondent a copy of the 9.20 Order. Respondent received the 9.20 Order.
- 5. The 9.20 Order became effective on April 22, 2011. Thus Respondent was ordered to comply with subdivision (a) and/or (b) of rule 9.20 of the California Rules of Court no later than on or about May 22, 2011, and was ordered to comply with subdivision (c) of rule 9.20 no later than on or about June 1, 2011.
- 6. Respondent has failed to file with the clerk of the State Bar Court a declaration of compliance with rule 9.20 (a) and (b), California Rules of Court, as required by rule 9.20(c).
- 7. By not filing a declaration of compliance with rule 9.20 in conformity with the requirements of rule 9.20(c), Respondent failed to timely comply with the provisions of the 9.20 Order requiring compliance with rule 9.20, California Rules of Court. By the foregoing conduct, Respondent willfully violated rule 9.20, California Rules of Court.
