TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

By motion filed April 5, 2016, respondent David Laurence Naples requested to modify the probation condition to extend the time within which he could pay restitution based on financial difficulties. Specifically, he asked for an extension of six months to pay the restitution.¹

On April 11, 2016, the Office of Probation of the State Bar of California, represented by supervising attorney Terrie Goldade (Office of Probation), opposed the request.

Having carefully considered respondent's motion and the Office of Probation's response, the court concludes that respondent's financial condition warrants an extension of time to pay the restitution.

¹ Respondent asked for an extension to October 26, 2016, but in the same motion, he also asked for an extension until April 25, 2017. The court finds a six-month extension is a reasonable request.

Good cause appearing, the court **GRANTS** respondent's motion and **ORDERS** that the probation condition of restitution be modified, such that respondent must pay the entire amount of restitution (principal and interest) due Dennis and Petra Spinelli (\$3,525 plus interest); Josephine Marin (\$3,500 plus interest); Marie Francisco² (\$3,500 plus interest); Paul Castillo (\$3,500 plus interest); and Alfred Fuentes, Jr. (\$3,500 plus interest) (or reimburse the Client Security Fund, to the extent of any payment from the fund to Dennis and Petra Spinelli; Josephine Marin; Marie Francisco; Paul Castillo; and Alfred Fuentes, Jr., in accordance with Business and Professions Code section 6140.5) on or before **October 26, 2016**, and furnish satisfactory proof to the Office of Probation on or before November 4, 2016.

IT IS SO ORDERED.
