TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On April 20, 2016, the court had granted respondent David Laurence Naples's request to modify the probation condition to extend the time within which he could pay restitution based on financial difficulties. He was given an extension of six months until October 26, 2016, to complete his probation conditions. On October 17, 2016, respondent asked for an extension of an additional six months to pay the restitution – April 25, 2017.

On November 3, 2016, the Office of Probation of the State Bar of California, represented by supervising attorney Terrie Goldade (Office of Probation), opposed the request, questioning respondent's inability to pay restitution in view of his and his spouse's total monthly income of \$10,250.

The court shares the Office of Probation's concerns. Yet, good cause appearing and in light of his gainful employment, the court GRANTS respondent's motion one last time and

ORDERS that the probation condition of restitution be modified, such that respondent must pay the entire amount of restitution (principal and interest) due Dennis and Petra Spinelli (\$3,525 plus interest); Josephine Marin (\$3,500 plus interest); Marie Francisco (\$3,500 plus interest); Paul Castillo (\$3,500 plus interest); and Alfred Fuentes, Jr. (\$3,500 plus interest) (or reimburse the Client Security Fund, to the extent of any payment from the fund to Dennis and Petra Spinelli; Josephine Marin; Marie Francisco; Paul Castillo; and Alfred Fuentes, Jr., in accordance with Business and Professions Code section 6140.5) on or before April 25, 2017, and furnish satisfactory proof to the Office of Probation on or before May 1, 2017.

IT IS SO ORDERED.
