This motion was filed by respondent Peter L. Nisson on January 2, 2013, seeking relief from (1) the prior cost award in the captioned matter and (2) his obligation to pay restitution on or before January 10, 2013 [sic]. In support of that motion, he filed a signed declaration and signed financial statement. The only information provided in the financial statement, or called for by it, is that he is currently receiving SSI or SSP. On January 2 and 7, 2013, the State Bar and Office of Probation filed oppositions to the motion.

Respondent's obligation to pay costs has already been the subject of a court order allocating it over two years. NO GOOD CAUSE having been shown, the motion for further judicial relief from the prior cost award is DENIED.

Respondent's stipulated obligation to make restitution payments included a deadline of six (6) months after the Supreme Court's order became effective. Given that this time period is less than the one year period that is normally allowed, and evidence that fulfilling this obligation by that deadline may be financially impossible due to recent factors beyond Respondent's control, the deadline for Respondent to comply with this restitution obligation is extended to July 3, 2013.
