**ORDER GRANTING RESPONDENT'S
MOTION TO MODIFY CONDITION OF
PROBATION; ORDER GRANTING
MOTION TO EXTEND TO TIME TO PAY
DISCIPLINARY COSTS.**

Introduction

This matter is before the court on respondent Tanya Cora Zerounian's November 22, 2013, motion for modification of condition of probation and time to pay disciplinary costs. The State Bar Office of Probation (OP) and Office of Chief Trial Counsel (OCTC) filed responses on November 26, 2013. The Respondent is represented by attorney Paul J. Virgo. The OP is represented by Supervising Attorney Terri Goldade and the OCTC is represented by Assistant Chief Trial Counsel Dane Dauphine.

After careful review of the motion to modify the terms of probation and the OP's response in-opposition, the court GRANTS the motion, good cause having been shown. Accordingly, restitution payments as previously ordered will commence on May 1, 2014. All restitution payments must be completed by the conclusion of the previously order probationary period.

After careful review of the motion to extend time to pay disciplinary costs and the OCTC's response in non-opposition, the court GRANTS the motion, good cause having been

shown. Accordingly, disciplinary costs are to be paid in equal amounts prior to February 1 for the following membership years: 2015, 2016, and 2017.


