On September 26, 2018, the Supreme Court filed an order stating:

“The petition for a writ of review filed by the State Bar is denied. [¶] The matter is remanded to the State Bar Court to consider whether dismissal without prejudice would be proper.”

On October 18, 2018, the Office of Trial Counsel of the State Bar (OCTC) filed a motion for dismissal of this case without prejudice and requested that the matter be remanded to the Hearing Department for further proceedings. On October 19, 2018, we issued an order allowing respondent Rita Mahdessian and OCTC to file briefs addressing the issue of whether dismissal of this case without prejudice would be proper. On November 5, 2018, OCTC filed a response.¹

Finding good cause, the opinion in the matter of RITA MAHDESSIAN, filed on June 27, 2018, is modified as follows:

On page 2, line 13 and page 17, line 13, the word “with” is changed to “without.”

¹ On October 29, 2018, we rejected respondent’s response for filing due to an improper proof of service. A proof of service must accompany all documents that are submitted for filing. (Rule Proc. State Bar, rules 5.26(A), 5.27(a); State Bar Ct. Rules of Prac., rule 1112(a).)

OCTC's request for a remand is denied. (See Rule Proc. State Bar, rule 5.123(C) [setting forth procedure after dismissal without prejudice].)


