This matter is before the court on Raymond Roy Miller's September 6, 2013 petition for relief from the Supreme Court's July 10, 2013 order assessing costs against him or, in the alternative, for an extension of time to pay costs. (Rules Proc. of State Bar, rule 5.130(B).) The Office of the Chief Trial Counsel of the State Bar of California (OCTC) opposes Miller's request for relief from the order assessing costs. With respect to Miller's alternative request for an extension of time to pay costs, OCTC does not oppose Miller obtaining a two-year extension of time to pay costs.<sup>1</sup>

**ORDER**

Hardship, special circumstances, and other good cause having been shown, the court orders that Raymond Roy Miller's September 6, 2013 petition is GRANTED to the extent that the time in which Raymond Roy Miller must pay the costs assessed against him in the Supreme Court's July 10, 2013 order in *In re Raymond Roy Miller on Discipline*, case number S201427

(State Bar Court case number 11-O-16029) is EXTENDED as set forth *post*. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)

Raymond Roy Miller must pay one-fourth of the costs with his State Bar of California membership fees for each of the years 2015, 2016, 2017, and 2018. If Raymond Roy Miller fails to pay any installment as described above, or as may be hereafter modified by the State Bar Court, the remaining unpaid balance of the costs is due and payable immediately. Until paid in full, the costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
