This matter is before the court on Mario Estuardo Diaz's August 8, 2014, motion for extension of time to pay discipline costs. On August 28, 2014, the Office of the Chief Trial Counsel of the State Bar of California filed a statement of nonopposition to the motion.

ORDER

Hardship and other good cause having been shown, the court orders that Mario Estuardo Diaz's August 8, 2014, motion for extension of time to pay discipline costs is GRANTED, and the time in which Mario Estuardo Diaz must pay the disciplinary costs imposed on him in the Supreme Court's June 9, 2014, order in *In re Mario Estuardo Diaz on Discipline*, case number S217566 (State Bar Court case number 11-O-16037) is EXTENDED as set forth below. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)

Mario Estuardo Diaz must pay 1/36th of the costs no later than the first day of each month for 36 consecutive months beginning November 1, 2014. Unless this payment schedule is hereafter modified by the Supreme Court or the State Bar Court, if Mario Estuardo Diaz fails to timely make any of these 36 monthly payments, then the remaining unpaid balance of the costs is



due and payable immediately. Until the costs have been paid in full, the costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.


