On May 21, 2014, respondent Verne Craig Scholl requested for relief from or extension of time to pay disciplinary costs imposed by the January 30, 2014 Supreme Court order, case No. S214624, based on his financial hardship.

On June 11, 2014, Assistant Chief Trial Counsel Dane C. Dauphine of the Office of the Chief Trial Counsel of the State Bar of California (State Bar) opposed relief from payment at this time because the costs are not due.

No good cause appearing, respondent's request to waive costs is hereby **DENIED**.

But in view of respondent's financial hardship, the court hereby **ORDERS** that respondent's time during which to pay the disciplinary costs in S214624 be extended and that one-third of the costs must be paid with his membership fees for each of the years 2015, 2016, and 2017. If Verne Craig Scholl fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately. The

payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
