The court's April 19, 2013 Decision in the above entitled matter is amended as follows:

On page 14 of the Decision, add the following conditional standard 1.4(c)(ii), Standards for Attorney Sanctions for Professional Misconduct, as a probation condition:

1. (c) If Respondent remains suspended for two years or more as a result of not satisfying the preceding requirement(s), he must also provide proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law before his suspension will be terminated. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.4(c)(ii).)



rules 5.151 or 5.157 of the Rules of Procedure of the State Bar will be calculated from April 19, 2013, the date the Decision was served on the parties.


