On February 10, 2015, Michael Anthony Cisneros ("Respondent"), filed a motion seeking an extension of time to pay the disciplinary costs over a period of twelve months or, an extension of time to pay the costs for a period of sixty days. On February 24, 2015, the Office of the Chief Trial Counsel of the State Bar of California (State Bar), by Brandon K. Tady, filed an opposition to Respondent's motion for relief from costs.

Respondent's motion is **GRANTED** as he has established sufficient hardship and good cause to grant him an extension of time to pay the costs in twelve monthly payments.

Accordingly, the time to pay the costs imposed on him in the above-captioned matter is extended. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)

Beginning immediately, Respondent is ordered to pay \$250 per month for eleven (11) months and to pay a final lump sum payment of \$4,488.00 in the twelfth month.

If he fails to pay any installment as described above, or as may be hereafter modified by the State Bar Court, the remaining unpaid balance of the costs is due and payable immediately.

Until they are paid in full, the costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
