

In the Matter of: MICHAEL WAYNE CHAMP, A Member of the State Bar, No. 95784	Case No: 11-O-18914 ORDER EXTENDING TIME FOR PAYMENT OF COSTS

This is Respondent's fourth request for relief from his obligation to pay the disciplinary costs ordered in the captioned matter. The original amount of those costs was \$15,782.56. Although Respondent has paid a portion of the costs, the balance remaining is said to be \$12,626.05.

Respondent's original request for an extension of the time to pay the assessed costs resulted in this court allowing Respondent to pay the costs in five annual installments. While Respondent made an initial payment toward the costs, in November 2014 he requested that the schedule of payments be delayed for a year, with the first of the five payments being due in 2016, rather than 2015. That request was granted in December 2014.

Respondent then made the first installment payment, then due in 2016, but, on February 8, 2017, filed a motion to have the balance of the payments be delayed for an additional year with the next installment payment being due in 2018. In support of that request, he provided a declaration and financial statement showing his inability to pay the required costs without financial hardship.

On February 16, 2017, the State Bar filed a response to the motion, indicating that it did not object to a further extension being granted, but asking that the overall duration of the installment payment schedule be compressed by one year.

On February 23, 2017, this court issued an order modifying the installment plan to delay its continuation for one year. Hence, one-fourth of the remaining costs was required to be paid by Respondent with his membership fees for each of the years 2018, 2019, 2020 and 2021. All of the other terms of that order remained in effect.

On May 14, 2018, Respondent filed the instant motion, once again seeking to have complete relief from his obligation to pay the disciplinary costs in this matter or, in the alternative, to delay the due date for the installment payment due in 2018. In support of that request, he provided a declaration and financial statement showing his inability to pay the required costs without financial hardship. On May 25, 2018, the State Bar filed an opposition to any reduction in the overall amount of the costs that Respondent is obligated to pay, but not opposing a further extension of the existing due date.

Good cause appearing, the existing installment plan is modified to delay its continuation for one year. Hence, one-fourth of the remaining costs (i.e., \$3,156.51) is required to be paid by Respondent with his membership fees for each of the years 2019, 2020, 2021, and 2022. All of the other terms of that order remained in effect.

IT IS SO ORDERED.


