On August 16, 2018, we issued an order suspending respondent Eric Bryan Seuthe from the practice of law in this state effective September 10, 2018, pending proof of passage of the Multistate Professional Responsibility Examination (MPRE) for his failure to pass within the time prescribed in the Supreme Court order filed June 23, 2017. (Cal. Rules of Court, rule 9.10, subd. (b).) On August 17, 2018, respondent filed a motion for extension of time to take and pass the MPRE. On August 23, 2018, the Office of Probation of the State Bar filed an opposition.

Finding good cause, respondent's motion is granted. Respondent must provide proof of passage of the November 10, 2018 MPRE within ten days of his receipt of the results.

The suspension imposed by our order filed on August 16, 2018 is terminated, effective upon the filing of this order. (Cal. Rules of Court, rule 9.10, subd. (b).) This order does not limit or alter a suspension order imposed on respondent in any other discipline or regulatory matter.<sup>1</sup>


