

On December 20, 2013, we issued an order placing respondent Allison Christine Worden on interim suspension, effective January 15, 2014, as a result of her conviction of one count of violating Penal Code section 182, subdivision (a)(5) (conspiracy to obstruct justice), and two counts of violating Vehicle Code section 40500, subdivision (d) (destruction of traffic citation). On January 6, 2014, respondent filed a motion to delay and to vacate order of interim suspension, arguing, among other things, that the interim suspension order would impose a degree of discipline more severe than the probable final discipline if her conviction is not reversed on appeal. On January 21, 2014, the State Bar filed its opposition. We temporarily stayed respondent's suspension pending our ruling on her motion.

Finding good cause, we grant respondent's motion and the interim suspension order is stayed. The State Bar is hereby ordered to provide a report regarding the status of respondent's criminal appeal no later than November 21, 2014, or sooner if changed circumstances warrant further consideration of interim suspension. The transmittal of respondent's conviction, the interim suspension order and this order will be posted on the State Bar's website pending resolution of this matter.


