NUNC PRO TUNC ORDER MODIFYING PROBATION CONDITION AND EXTENDING TIME FOR PAYMENT OF RESTITUTION

TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On November 4, 2015, respondent Gayle Anne-Marie Gutekunst filed a motion to modify probation to extend the time within which she could pay restitution based on financial difficulties. Specifically, she asked for an extension of eight months to pay the interest of \$23,379.04. She had paid the principal in April 2015.

On November 19, 2015, the Office of Probation of the State Bar of California, represented by supervising attorney Terrie Goldade (Office of Probation), opposed the request, arguing, among other things, that respondent's probation had terminated on October 25, 2015.

Having carefully considered respondent's motion and the Office of Probation's response, the court concludes that respondent's financial condition warrants an extension of time to pay the remaining balance of restitution.



Good cause appearing, the court **GRANTS** respondent's motion to modify the probation condition to extend the time for restitution payment and **ORDERS**, nunc pro tunc, the following:

1. Respondent's probation period is extended by eight months to June 30, 2016;

 Respondent must comply with the applicable conditions of probation imposed by the Supreme Court in S212056, including the quarterly reports;

3. Respondent must pay the entire balance of restitution (\$23,379.04 in interest) due James and Paula Steinway (or reimburse the Client Security Fund, to the extent of any payment from the fund to James and Paula Steinway, in accordance with Business and Professions Code section 6140.5);

4. Respondent must make minimum quarterly payments of \$8,000 due James and Paula Steinway (or reimburse the Client Security Fund, to the extent of any payment from the fund to James and Paula Steinway, in accordance with Business and Professions Code section 6140.5);

Respondent's first minimum installment payment of \$8,000 is due on or before
 December 31, 2015;

6. Respondent must provide satisfactory proof of payment to the Office of Probation with each quarterly probation report; and

7. Respondent must make any necessary final payment in order to complete the interest payment of restitution, in full, no later than 30 days (May 31, 2016) prior to the expiration of the period of probation.

IT IS SO ORDERED.
