On July 31, 2013, the court filed an order vacating the submission date of this matter and ordering the State Bar of California, Office of the Chief Trial Counsel (State Bar) to show cause, in writing, as to why respondent's default should not be vacated and/or the petition for disbarment denied, based on the propriety of the service of certain documents filed in this matter.

On August 2, 2012, the State Bar filed its response to the order to show cause. In its response, the State Bar requested that the court withdraw the State Bar's disbarment petition and vacate the default entered against respondent. The State Bar also acknowledged that it would reserve the NDC on respondent by certified mail.

The NDC filed in the above-entitled matter on July 13, 2012, was not properly served on respondent pursuant to rule 5.25 of the Rules of Procedure of the State Bar<sup>1</sup>, which requires that an initial pleading be served on a member at the member's State Bar membership records address and, if it is in the United States, it must be served by certified mail, return receipt

requested. Accordingly, the court's September 13, 2012, order entering respondent's default and enrolling him inactive under Business and Professions Code section 6007, subdivision (e), is hereby vacated, nunc pro tune, to September 13, 2012.

Similarly, the State Bar's Petition for Disbarment filed on March 29, 2013, was not served on respondent by certified mail, return receipt requested, as required by rule 5.85(C). Accordingly, the court grants the State Bar's request to withdraw its Petition for Disbarment.

IT IS SO ORDERED.
