On June 10, 2013, respondent Emeka Godfrey Onwualu filed a motion to set aside his default for failing to appear at trial. The State Bar opposes the motion.

The law favors a trial on the merits. Doubts in deciding whether to grant a motion to set aside a default are resolved in favor of the party seeking relief, and if that party has moved promptly for relief, only slight evidence will justify an order granting relief. (Elston v. City of Turlock (1985) 38 Cal.3d 227, 233.) Respondent attended the funeral of his sister in Africa. He was scheduled to return to the United States before the trial date. He became ill and was not able to return until after the trial date. Although there was some delay in seeking to set aside the default, it has not been significant.

The court concludes that respondent's failure to appear at trial was a result of his mistake, inadvertence, surprise, or excusable neglect within the meaning of Code of Civil Procedure, section 473, subdivision (b). The motion is therefore granted.
