# ORDER MODIFYING PROBATION CONDITION (ETHICS SCHOOL)

On May 22, 2015, respondent Nia Lloyd Woolliscroft requested that the court modify her Ethics School probation condition. Specifically, respondent seeks an extension of time in which to attend a session of the State Bar Ethics School and provide proof to the State Bar of California Office of Probation (Office of Probation) of her attendance at such session and passage of the test given at the end of the session.

On May 28, 2015, the Office of Probation by and through Supervising Attorney Terrie Goldade filed an opposition to respondent's motion. Thereafter, on June 3, 2015, respondent filed a reply to the Office of Probation's opposition.

Good cause having been shown, respondent's motion to modify her Ethics School probation condition is GRANTED. Accordingly, the time in which respondent must attend a session of Ethics School and provide proof of her attendance at said session, as well as proof of



passage of the test give at the end of the session, is extended to November 23, 2015. All other terms and conditions of probation remain the same.
