On July 7, 2014, respondent Gene O'Brien (respondent) filed a motion, based on financial hardship, seeking relief from paying the full amount of costs assessed by the Supreme Court in order S216883 effective June 12, 2104, and extending his time to pay those reduced costs.

The State Bar of California, Office of the Chief Trial Counsel (State Bar) filed an opposition to respondent's motion. The State Bar opposed a reduction of the amount of costs but did not object to a payment plan with an acceleration clause if respondent did not comply with the payment plan terms.

After reviewing and considering respondent's motion and the State Bar's opposition thereto, the court finds that good cause exists to grant respondent partial relief from the assessed costs and an extension of time to pay those costs.

IT IS THEREFORE ORDERED that costs awarded in this matter be reduced to \$8,021 and one-third of the costs must be paid with his membership fees for each of the years 2015,



2016 and 2017. If respondent fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
