

On June 25, 2013, respondent B. Kwaku Duren filed a motion for reconsideration to modify conditions of probation. The motion was made on the grounds of financial hardship. (Rules Proc. of State Bar, rule 5.300). The Office of Probation (OP), by Supervising Attorney Terri Goldade, filed a response in opposition on June 27, 2013.


After a careful review of the motion and the opposition, the court GRANTS the motion, good cause having been shown. Accordingly, beginning January 1, 2014 and continuing on the first of each month up to and including July 1, 2014, respondent will pay \$500 per month in restitution to Carolyn Williams.

Beginning August 1, 2014 and continuing on the first of each month, respondent will pay \$1,000 per month in restitution to Carolyn Williams until all restitution owed to Williams

have been paid.


