On July 20, 2018, Victor Jacobovitz (Respondent) filed a one-paragraph motion seeking an extension of time for him to pay costs in the captioned three matters. In support of his motion, Respondent only provided a financial statement. He did not provide this court with the amount of the costs assessed in the three cases; did not attach a declaration indicating whether and to what extent he had paid any portion of the installment payment plan approved by this court in 2015 in case No. 14-O-03330; and did not indicate what specific installment plan he was seeking.

On July 24, 2018, the State Bar filed an opposition to the motion.

On July 30, 2018, this court issued an order denying the motion.

On August 8, 2018, Respondent filed a Second Motion for Payment Plan and Extension of Time to Pay Disciplinary Costs. This motion included a declaration by Respondent and a proposed payment plan of \$500 each month until the cost obligation has been extinguished. The motion, however, did not provide the total amount of costs that are owed.

On August 10, 2018, the State Bar filed another opposition to Respondent's request for a payment plan. In that opposition, the State Bar criticized Respondent for again failing to provide this court with the total amount of costs that are owed, but did not itself provide this court with that amount, although it was readily available to it.

This court has now been informed by the Finance Office of the State Bar that the total amount of costs owed by Respondent is \$16,693.55. Applying the requested payment plan proposed by Respondent would indicate that it will take approximately three years for the total amount of these costs to be paid.

Respondent's financial statement indicates that the payment plan he is proposing is quite reasonable and that he does not have either the income or assets sufficient to pay the total amount of unpaid costs at the present time or within the near future.

Therefore, good cause appearing, the court grants Respondent's motion for relief as follows:

Respondent is hereby ordered to pay \$500 each month to the State Bar toward the unpaid costs in the captioned matters. Those monthly \$500

payments are due on the first day of each month, with the first of the payments being due on November 1, 2018. If Respondent fails to pay any of these monthly installment payments more than 10 days after its due date without the prior written approval of the State Bar or the State Bar Court, the remaining unpaid balance of the costs will be due immediately and be enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. Except as provided above, the time for Respondent to pay all of the disciplinary costs owed to the State Bar as a result of the captioned matters is extended until November 1, 2021. If for some reason all of those costs have not been paid by virtue of the monthly payment plan by that date, the balance of any remaining unpaid costs must be paid in full on or before November 1, 2021.

**IT IS SO ORDERED.**


