On December 3, 2013, respondent Karla Ruiz (respondent) filed a motion for an extension of time to take and pass the State Bar's Ethics School and the Multistate Professional Responsibility Examination (MPRE). On December 5, 2013, the State Bar, Office of Probation filed a response stating that it does not oppose an extension up to July 1, 2015, so long as respondent's probation period is extended to July 1, 2015.

Having considered the parties' contentions and good cause appearing, the court orders as follows:

1. The court grants an extension of time for respondent to take and pass the MPRE. (Cal. Rules of Court, rule 9.10(b).) Respondent must take, and provide proof of passage of the MPRE to the State Bar's Office of Probation on or before July 1, 2015;
2. The court grants an extension of time for respondent to take and provide proof of completion of the State Bar's Ethics School. (Rules Proc. of State Bar, rule 5.300(B).) Respondent must take and provide proof of completion of the State Bar's Ethics School to the State Bar's Office of Probation on or before July 1, 2015; and

3. Respondent's period of probation is extended to July 1, 2015. (Cal. Rules of Court, rule 9.10(c).)

IT IS SO ORDERED.


