This matter is before the court on Clinton Edward Parish's June 26, 2015 motion for relief from order assessing costs. On July 15, 2015, the Office of the Chief Trial Counsel of the State Bar of California filed an opposition to Parish's motion for relief.

In his motion, Parish seeks relief from the review department's February 5, 2015 order awarding costs in this proceeding to the State Bar of California in *In the Matter of Parish* (Review Dept. 2015) 5 Cal. State Bar Ct. Rptr. 370, 379. Under the review department's order, Parish has been assessed \$20,732.75 in disciplinary costs.

Even though Parish has not established sufficient grounds of hardship, special circumstances, or other good cause to grant him relief from all of the \$20,732.75 in assessed costs, Parish has established sufficient grounds of hardship, special circumstances, and other good cause involving his loss of employment and other financial difficulties to grant him relief from 75 percent of the \$20,732.75 in assessed costs, which equals \$15,549.57, and to grant him an extension of time to pay the remaining \$5,183.19 (\$20,732.75 less \$15,549.57) in costs.



ORDER

The court ORDERS that Clinton Edward Parish's June 26, 2015 motion for relief from costs is GRANTED to the extent that the disciplinary costs assessed against Parish under the review department's February 5, 2015 order in *In the Matter of Parish* (Review Dept. 2015) 5 Cal. State Bar Ct. Rptr. 370, 379 are reduced from \$20,732.75 to \$5,183.19 and that Clinton Edward Parish must pay one-fifth of the remaining \$5,183.19 in costs with his annual State Bar membership fees for each of the years 2016, 2017, 2018, 2019, and 2020. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)

The court further ORDERS that, if Parish fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court under Business and Professions Code section 6086.10, subdivision (c) and the Rules of Procedure of the State Bar, the remaining balance of the costs is due and payable immediately. (Rules Proc. of State Bar, rule 5.134.) The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
