On January 12, 2015, **Joanna Tooker Vogel** ("Respondent") filed a motion which sought an extension of time to take and pass the Multistate Professional Responsibility Examination ("MPRE"). On January 15, 2015, Office of Probation Supervising Attorney Terrie Goldade, filed an opposition on behalf of the State Bar. The court has carefully considered the motion and response and finds Respondent's request to take and provide proof of passage of the MPRE is consistent with protecting the public, the member's successful rehabilitation and, maintaining the integrity of the legal profession. Good cause having been shown, Respondent's motion to extend the time within which she must prove passage of the MPRE to the Office of Probation is **GRANTED**. Respondent is to provide proof of passage of the MPRE to the Office of Probation on or before June 1, 2015.


