On October 26, 2016, Robert Sibilia ('Respondent'), filed a motion requesting relief from the disciplinary costs assessed in the Hearing Department Decision, entered in the above-captioned matter. Respondent sought modification of the amount of disciplinary costs assessed against Respondent based on an incorrect assessment of certain costs incurred as to Respondent's former law partner, W. Stephen Lorenzo under Hearing Department case number 13-O-11520, which was severed from Respondent's above-referenced matters. In addition, due to financial hardship, Respondent sought an extension of time to pay the disciplinary costs he was ordered to pay in the instant matters.

On November 8, 2016, the Office of the Chief Trial Counsel (OCTC), by and through Senior Trial Counsel Kim Kasreliovich, filed a response to Respondent's motion. The OCTC did not oppose Respondent's requested 12 month extension of time to pay the disciplinary costs and agreed that the disciplinary costs should be reduced by \$466.50 to \$7,554.50. The disciplinary



costs of \$7,554.50 includes the costs of \$7,088 for a one-day trial and Respondent's share of the

investigation costs.

Based on the court's review of Respondent's motion and the State Bar's response thereto,

the court finds that Respondent has established hardship, special circumstances, and other good

cause under rule 5.130(B) of the Rules of Procedure of the State Bar as to warrant the following

order:

1. Respondent is granted an extension of time to pay \$7,554.50 in disciplinary costs. In

view of Respondent's financial hardship, the court orders Respondent to pay these disciplinary

costs along with his membership fees for 2017, pursuant to Business and Professions Code

section 6086.10. The payment of costs is enforceable both as provided in Business and

Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.
