TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On June 16, 2016, respondent Daniel Kieth Martin requested an extension of time to pay disciplinary costs imposed by the June 9, 2016 Supreme Court order, case No. S233441, based on his financial hardship.

On June 20, 2016, Deputy Trial Counsel Heather E. Abelson of the Office of the Chief Trial Counsel of the State Bar of California (State Bar) did not oppose an extension of time for respondent to pay disciplinary costs over two years, payable in 2017 and 2018.

GOOD CAUSE APPEARING, respondent's request for an extension of time to pay disciplinary costs is granted in that respondent's time during which to pay the disciplinary costs in S233441 is extended and that one-third of the costs must be paid with his membership fees for each of the years 2017, 2018 and 2019. If Daniel Kieth Martin fails to pay any installment as

described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
