The court's Decision, filed on December 10, 2015, is hereby amended as follows:

1. On page 47 of the Decision, at numbered paragraph 1.a.(ii), "\$2,900" is deleted, and in its place is inserted "\$3,495".
2. On page 47 of the Decision, at numbered paragraph 1.a.(viii), "\$4,185" is deleted, and in its place is inserted "\$4,095".
3. On page 48 of the Decision, at numbered paragraph 1.a.(xiii), "Fuod" is deleted, and in its place is inserted "Fuad".
4. On page 48 of the Decision, at numbered paragraph 1.a.(xv), "\$4,095" is deleted, and in its place is inserted "\$4,195". Also, at that same paragraph, "April 8, 2013" is deleted, and in its place is inserted "August 5, 2013".
5. On page 48 of the Decision, at numbered paragraph 1.a.(xvii), "\$3,295" is deleted, and in its place is inserted "\$5,795". Also, at that same paragraph, "August 28, 2013" is deleted, and in its place is inserted "September 13, 2013".


6. On page 48 of the Decision, at numbered paragraph 1.a.(xx), "Lucera" is deleted, and in its place is inserted "Lucero". Also, at that same paragraph, "\$1,650" is deleted, and in its place is inserted "\$2,445". Finally, at that same paragraph, "October 31, 2012" is deleted, and in its place is inserted "January 4, 2013".
7. On page 48 of the Decision, at numbered paragraph 1.a.(xxi), "Janetta" is deleted, and in its place is inserted "Jenetta". Also, at that same paragraph, "April 4 2013" is deleted, and in its place is inserted "April 4, 2013".

With the exception of the amendments set forth above, the Decision filed on December 10, 2015, remains unchanged.

The amendments ordered are not all clerical corrections. Accordingly, the time for filing a motion to reopen the record, for a new trial and/or for reconsideration of the court's December 10, 2015 Decision under rules 5.113, 5.114, and 5.115, respectively, of the Rules of Procedure of the State Bar and the time for filing a request for review of such Decision under rule 5.151 of the Rules of Procedure will be calculated from the date this Order is served on the parties.


