Since respondent Federico Rose Buenrostro,¹ State Bar Number 118996, has been convicted of violating title 18 United States Code section 371 (conspiracy to commit bribery and honest services fraud, and to defraud the United States), a felony involving moral turpitude, it is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law effective October 22, 2014, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.
