The firearm was a Springfield .40 pistol which was legally purchased and registered to James C. Nguyen. The sentence received for this conviction was court fees and penalties, informal probation for three (3) years. The sentence resulted from a plea bargain. All fines and penalties ordered have been paid.

FACTUAL SUMMARY:

On April 4, 2013, Member was arrested for possession of a handgun. On this date Member perceived a credible threat to the safety of his two children and to himself. Member called the police for assistance in connection with the perceived threat. When the police arrived Member immediately declared Member's weapon to police. Member was immediately arrested for possession of the weapon. The weapon had been legally purchased, owned and registered to Member.
