**ORDER REGARDING RESPONDENT'S  
MOTION FOR RELIEF FROM  
DISCIPLINARY COSTS**

On July 3, 2018, Jordan Tonya Louise Peters (Respondent), filed a motion seeking relief from State Bar disciplinary costs or, in the alternative, a reduction in the amount of the disciplinary costs from \$21,390.02 to \$2,000, based on financial hardship. Respondent's motion was supported by declaration which set forth information regarding her financial condition. On July 9, 2018, the Office of the Chief Trial Counsel of the State Bar of California (State Bar), by and through Kevin B. Taylor, Esq., filed a response in opposition to Respondent's motion for relief from costs.

While Respondent has not established good cause for the waiver of her disciplinary costs, Respondent has established sufficient hardship and other good cause to grant her an extension of time to pay the costs in five annual installments.

Accordingly, Respondent's request for a waiver of or reduction in disciplinary costs is **DENIED**. However, good cause having been shown, the court **GRANTS** Respondent an extension of time to pay the costs imposed on her in the above-captioned matter. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)



**IT IS FURTHER ORDERED THAT** respondent Jordan Tonya Louise Peters' time to pay the disciplinary costs associated with case No. 13-C-16396 be extended and that one-fifth of the disciplinary costs she owes shall be paid each year over the next five years. If she fails to pay any installment as described above, or as may be hereafter modified by the State Bar Court, the remaining unpaid balance of the costs is due and payable immediately. Until they are paid in full, the disciplinary costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. All other terms and conditions remain the same.

**IT IS SO ORDERED.**


