On the court’s own motion, the court’s Decision Including Disbarment Recommendation and Involuntary Inactive Enrollment Order (Decision) filed on March 6, 2014, is hereby amended as follows:

1. On page 3 of the Decision, the heading “Case No. 12-J-15596” is deleted, and in its place is inserted “Case No. 13-J-15596”.

2. On page 3 of the Decision, the fourth full paragraph beginning “Respondent then deposited . . . ,” line 3, “to” is deleted.

3. On page 8 of the Decision, under the heading “Multiple Acts of Misconduct,” “Std.1.2(b)(ii)” is deleted, and in its place is inserted “Std. 1.5(b)”.


4. On page 11 of the Decision, under the heading “Restitution,” numbered paragraph 2, line 1, “\$125,000” is deleted, and in its place is inserted “\$145,357.51”.


