On September 28, 2015, Respondent filed a motion in this case, seeking to modify a condition of his public reproof that was imposed on August 4, 2014. Specifically, Respondent requests that he be relieved of the requirement that he provide proof of passage of the Multistate Professional Responsibility Examination (MPRE), or, in the alternative, he be allowed additional time to provide proof of passage of the MPRE. The Office of Probation filed a response to the motion on September 29, 2015, indicating that it did not oppose the motion to extend time.

The Court DENIES Respondent's motion to be relieved of the requirement that he provide proof of passage of the MPRE, but GRANTS his request for additional time to provide proof of passage of the MPRE.

GOOD CAUSE APPEARING, Respondent's condition of reproof in this case is modified, such that he is now required to provide proof of passage of the MPRE by December 15, 2015.


