10 within 30 days of the time Respondent had knowledge of the imposition of any judicial sanctions
11 against Respondent by failing to report to the State Bar the \$2,125.00 in sanctions the court
12 imposed on Respondent on or about November 14, 2012, in connection with *In re the Marriage*
13 *of Lugo*, Superior Court of California, County of Kern, case no. R-1502-FL-6180, in willful
14 violation of Business and Professions Code section 6068(o)(3).
