ORDER EXTENDING TIME TO PAY COSTS

This matter is before the court on Susan Patricia Widule's March 10, 2014 motion for relief from the disciplinary costs that the Supreme Court previously imposed on her in this proceeding. The Office of the Chief Trial Counsel of the State Bar of California opposes Widule's motion for relief from costs, but does not oppose granting her an extension of time to pay the costs.

Widule has failed to establish sufficient hardship, special circumstances, or other good cause to grant her relief, in whole or in part, from the disciplinary costs assessed against her. Nonetheless, Widule has established sufficient hardship and other good cause to grant her an extension of time to pay the costs. Accordingly, the court will extend the time in which Widule must pay the costs. **kwiktag**[®] 048 621 534

ORDER

The court orders that Susan Patricia Widule's March 10, 2014 motion is GRANTED to the extent that the time in which Susan Patricia Widule must pay the costs imposed on her in the Supreme Court's November 13, 2013 order in *In re Susan Patricia Widule on Discipline*, case number S213057 (State Bar Court case number 13-O-10353) is EXTENDED as set forth *post*. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).)

Susan Patricia Widule must pay one-half of the costs with her State Bar of California membership fees for each of the years 2015 and 2016. If Susan Patricia Widule fails to pay any installment as described above, or as may be hereafter modified by the State Bar Court, the remaining unpaid balance of the costs is due and payable immediately. Until they are paid in full, the costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
