On March 24, 2014, the Supreme Court filed an order in this matter that required respondent to pay disciplinary costs of \$2,925, in which the amount due was to be paid in three equal, \$975 installments at the time respondent paid her membership fees for calendar years 2015, 2016, and 2017. On January 6, 2015, the State Bar Court modified that term due to the economic hardship of respondent. The modified order allowed respondent to pay the first installment, due for calendar year 2015 to be, instead, paid with her 2016 membership fees and the second installment due on her disciplinary costs.

On November 23, 2015, respondent filed another motion seeking to extend her time to pay disciplinary costs related to this matter, or, in the alternative, to be relived of such costs. In her motion, respondent contends her current situation continues to result in economic hardship, which is preventing her from paying disciplinary costs in this matter.

On November 30, 2015, the Office of the Chief Trial Counsel (OCTC) filed its response. Specifically, OCTC proposed that respondent pay her disciplinary costs of \$2,925 in three equal, \$975 installments at the time respondent pays her membership fees for calendar years 2017, 2018, and 2019. OCTC also indicates that respondent has agreed to this modification of her payment terms.

GOOD CAUSE APPEARING, respondent's motion is **GRANTED** as to respondent's request for an extension of time to pay disciplinary costs. Respondent's alternative request for full or partial relief from payment of disciplinary costs is **DENIED**, no good cause having been shown.

Respondent's time to pay the disciplinary costs associated with case no. 13-O-10689 (S201790) is extended, and respondent shall pay her disciplinary costs of \$2,925 in three equal, \$975 installments at the time respondent pays her State Bar membership fees for calendar years 2017, 2018, and 2019.

Further, if respondent fails to pay any installment of disciplinary costs within the time provided herein, or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and

payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of State Bar, rule 5.134). The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


