

TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On May 23, 2014, respondent Gordon Dean Brown sought an extension of time to pay costs imposed by the March 26, 2014 Supreme Court order, case No. S215977, based on his financial hardship.


On June 9, 2014, Supervising Senior Trial Counsel Robert A. Henderson of the Office of the Chief Trial Counsel of the State Bar of California (State Bar) did not oppose such an extension.

In view of respondent's financial hardship, the court hereby **ORDERS** that respondent's time during which to pay the disciplinary costs in S215977 be extended and that one-fifth of the costs must be paid with his membership fees for each of the years 2015, 2016, 2017, 2018, and 2019. If Gordon Dean Brown fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately. The

payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


