On June 15, 2015, respondent Jens Edward Hoekendijk (respondent), by and through his attorney, Samuel C. Bellicini, filed a motion for an extension of time to take and pass the Multistate Responsibility Examination (motion). In his motion, respondent states that although he attempted to register in February 2015, for the Multistate Professional Responsibility Examination (MPRE), which was offered in March 2015, that "test date was unavailable." He did, however, note that the MPRE will be offered on August 15 and November 7, 2015, as well as on March 19, 2016. Consequently, respondent requests that the court grant him an extension of time to take and pass the Multistate Responsibility Examination (MPRE) until April 26 2016,

i.e., until after the release of the results of the March 19, 2016 examination. Respondent further

notes that he has registered to take the August 15, 2015 examination.

On June 17, 2015, the State Bar Office of Probation (Office of Probation) filed a response

to respondent's motion, stating its opposition to extending the time for respondent to take the

MPRE.

Having carefully considered respondent's motion and the State Bar's opposition thereto,

the court concludes that respondent's request to take and provide proof of passage of the MPRE

is consistent with protecting the public; the member's successful rehabilitation; and maintaining

the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).)

Nonetheless, the court finds no good cause to grant more than a nine month extension of

time in which to provide proof of passage of the MPRE. Thus, respondent's request for an

extension of time until April 26, 2016, in which to provide proof of passage of the MPRE is

DENIED.

However, good cause having been shown, respondent's motion to extend the time

within which to take and pass the MPRE is GRANTED until December 22, 2015.

Respondent must, therefore, provide proof of passage of the MPRE no later than December 22,

2015.

IT IS SO ORDERED.
